IMPORTANT ANNOUNCEMENT

When it is time to renew your 2025 membership with the New York State Retired Teachers' Association DBA Retired Educators of NY (RENY), you will notice an increase in the dues amount. Yearly dues for the past ten years have been a modest \$30.00. Out of necessity, the annual dues beginning January 1st, 2024 (for dues to be paid through 2025) are being raised to \$39.00, Lifetime membership dues will be \$900. This increase was decided upon after a great deal of consideration. The financial situation calls for increased revenue since RENY expenditures are not keeping pace with income. This is despite the many measures that have been taken to reduce expenses. As you know from purchasing groceries, clothing, gas, etc., the cost of many items has been going up. The increased revenue will help RENY move toward a balanced budget and remain stable and strong.

This increase does NOT affect current LIFE Members or those members currently OVER 90 years of age.

Members like you are the focus of this organization which works solely on behalf of retired educators. You can feel confident that this non-profit organization run by its members will continue to represent you very well. RENY will continue to concentrate on its two major goals...providing excellent member services and acting to ensure that government decisions and legislation protect your interest as retirees.

We are proud of what RENY has been able to accomplish through the years. We look forward to a bright future. This would not be possible without your continued support. Thank you.

There were excellent workshops on the following day, many of which highlighted the Convention Theme: Beauty, Bounty, and Bravery. All of the others were topics of general interest such as an update from the Teacher Retirement System and presentations on personal health and wellness, investing and the economy, aging gracefully and dealing with grief after the loss of a loved one. All of the presentations were well done and professional. There was something to interest almost all convention goers! Some of these were videotaped and will be posted on our website. The Annual Meeting was held following lunch on Thursday. We were fortunate to have our Parliamentarian, Carol Schilansky, with us in person this year! She was very professional as always and helped us conduct a productive and smooth-running meeting. During this meeting, we adopted a budget for 2023-24. This adopted budget has revenues of \$268,500 and expenses of \$332,250. Without the addition of \$63,750 from our endowment, the budget for 2023-24 would not be in balance. As I mentioned in previous messages, **we need to increase our revenues**. We have taken a step forward by making changes in membership dues, but we still need to look for additional ways to increase our revenues. Many have said that the United States does not have a revenue problem. It has a spending problem. We have the exact opposite problem. **Not enough revenue!**

Delegates also approved three resolutions and adopted an amendment to the Bylaw concerning investments of RENY funds. More detailed information about the Bylaw passed and the resolutions can be found inside. One of the amendments to the Bylaws, namely the Bylaw to reduce the percentage rebate to zones did not pass. Sixty-nine, (69) in favor; and forty-eight, (48) opposed. (A 2/3 vote in favor is required to amend a Bylaw.)

In the evening, attendees put on Mardi Gras masks, beads, feathers, and festive dresses for a Masquerade cocktail party. There was a cash bar and light refreshments in the form of fruit, vegetables, crackers, and cheese. The evening culminated in a lively Trivia Contest with a full complement of teams. Taking top honors were Team Trivia Gurus, Team Whiners and Team Rumble Ponies. Special thanks to the North Central Zone under the leadership of **Woody Lyndaker** and his Working Group of **Kathy Allan, Barbara Cole-Russell, Patty Corey, Doug and Pat Dietrich, Toni Gigliotti, Linda Holley, Teresa Lyndaker, Jackie Maloney, Rick and Linda Morris, and Pat Newell**. You were an effective team and put on a terrific Convention!

The Retired Educators of New York continues to be a great organization for teachers, administrators, and support staff. This Association is a great place to meet new people, maintain social contacts and to continue to learn and grow. RENY also continues to safeguard benefits negotiated for you by your unions. This September, retired educators received a substantial COLA increase of \$37.50 per month. This benefit could not have been obtained without the collective action of your Association as well as teacher and administrator unions. Members should keep that in mind as they renew their membership and persuade other retired educators to join this great association.

Supplemental Health Insurance provided to retired educators is under attack in some parts of the state. Your Association is continuing to advocate for a state law requiring school districts to continue to provide the same level of Supplemental Health Insurance to retirees as to active teachers. Please read more about proposed legislation inside.

As the year unfolds, my wife and I will continue to visit zones. To date, we have visited the WZ, CZ, EZ, NCZ and CWZ. We hope to visit more zones before the completion of my term of office. As I close this message, I remind you that RENY is the only state-wide organization that works exclusively on behalf of retired educators. It is a great organization, and I thank you for continuing to be a part of it. Please help us to grow membership by persuading a friend or colleague to join.

LEGISLATIVE ACTION COMMITTEE By Mary Johnson*CR, VP for Legislation

I hope everyone had a chance to enjoy this nice Fall weather. Fall is the start of the busy time for the Legislative Action Committee. At our meeting in early November, we started discussing possible positions we will take and plan to advocate for bills to support those priorities. Thanks to **Janice Mullins**, State Legislation Sub-committee chair, we will have lots of information to review. We will review the status of past bills that we supported and look for new ones to be introduced in January 2024. We will review the resolutions passed at the Annual Meeting and any past issues that have not been resolved.

The teacher shortage is top of mind. Some research suggests that the Tiers 5 and 6 may have an impact on the decisions potential teachers make about their career choices. If college graduates find that their salary will be reduced by contributions to the Retirement System and that their potential income after retirement will be significantly less than peers in lower tiers, they may head in a different direction. Improvements to Tiers 4,5 and 6 need to be made for teachers currently working under those retirement restrictions. The LAC zone chairs will also take a look at issues that were supported in the past and have not been fully addressed by the legislature. One of those past priorities is the protection of the health benefits that were promised to our members at retirement. We will be following bills that assure there will be no diminishment of health care provisions that were promised regardless of where that retiree resides. We will continue watching and advocating for the Elder Abuse Protective Act. Also, assuring on-site mental health programs and services are provided to all students will be considered for this year's program. We also keep in mind the need for an improvement in the base of the COLA determinations.



Bolstering advocacy teams in each region is a must. Some of the advocates in recent years are no longer able to contribute to this work. While diminishing membership is a problem for the entirety of RENY, there must be members who just haven't given the idea of advocacy much thought.

COMMUNITY SERVICE REPORT By Eileen Holmes*CR



From November 2022 through the Winter, Spring and Summer of 2023, RENY Community Service had an outstanding year. All ten zones engaged in projects that helped people and organizations across New York State. Many thanks to zone chairs: **Joan Handfield, Joyce Notaricola, Angelo Grande*CR, Art Menard, Alice Galvin, Cheryl Fischer, Mary Suffern, Toni Gigliotti and Patty Corey, Ann Marie Wik** and Central Zone President **Ray Pitcher** for their leadership and efforts in organizing community service events.

The following sample of accomplished projects is a testament to the capabilities and generosity of our RENY members:

- ⇒ Scholarships were presented in the Eastern, North Central, Northern, Southeastern and Central zones. The Northeastern Zone provided an educator grant for an indoor greenhouse project that has grown into a very successful community-wide, hands-on program.
- ⇒ Many zones engaged in food and clothing collections. Southeastern zone units collected new socks and non-perishable foods for distribution to soup kitchens and homeless shelters. In the Central Zone, the Chenango unit donated to the Chenango County food pantry. The Long Island zone donated new clothing and personal hygiene items for needy veterans in Nassau County and the East End unit provided food and cases of bottled water to Maureen's Haven homeless shelter. The Western zone's Genesee unit collected socks, underwear and personal hygiene products for CASA, an agency that helps kids who are in contact with the court system. The North Central zone coordinated its annual Coats for Kids project, and the Eastern zone planned a sweater and coat drive. The Northeastern zone planned local food drives and in the Southern zone, food pantries in Bath, Corning, Painted Pony and Savona received donations.
- ⇒ Cultural and civic organizations continued to be an important part of RENY's Community Service efforts. The Northern zone donated to the Akwesasne Cultural Center and the Long Island zone's East End unit initiated a "Love Your Public Library" project and presented its first award to the Riverhead Library. Pictured to the right is Riverhead Library Director Kerri McMullen-Smith with EERTA's **Gini Stype**. In the Southern zone, Heritage Village and the Southeast Steuben Library received donations. The Western Zone gave a \$500 teacher grant for a reading improvement program and donated a grant to help fund an African American cultural presentation during Black History Month. The Central Western zone raised money for Relay for Life, the Long Island zone donated to Little Shelter Animal Rescue and Adoption, and the Eastern zone collected donations of food treats and toys for Pets Without People, an organization that helps homeless animals.



Community Service continues to be a vital and gratifying component of our organization. Many thanks to the delegates at the 2023 annual convention who donated non-perishable foods to the state-wide collection and made this annual project very successful. The host zone North Central provided the collection box and the donated items were "passed forward" to the 2024 host zone (Northeastern) for distribution in their area. I am hopeful this worthy project will continue for the third year at the 2024 convention.

BYLAWS COMMITTEE REPORT by William Tenity, Committee Chair



The Bylaws Committee presented two proposed bylaw changes at the Annual Meeting. Both Bylaw proposals went through the process set up in the Bylaws. Both proposals were requested by the Board of Directors. The Bylaws Committee met and recommended the changes to the BOD. The BOD received each proposal ten days before the meetings where they were to be voted on. The BOD passed each proposal by more than the two-thirds of the votes required for approval. Each zone voted at their annual meetings and at least two-thirds of the zones voted their approval. The proposals were then presented at the RENY Annual Meeting on October 12, 2023.

Proposition #1 IOAF (Investment of Association Funds) 2023 which modified how Association funds were to be invested was passed by all ten zones and was passed unanimously by the delegates.

Proposition #2 RODTZAOR (Remittance of Dues to Zones and Out-of-state Regions) 2023 would have changed the percentage of dues money for annual memberships returned to the zones from one-third (33-1/3%) to one quarter (25%). This was proposed because of the dues increase from \$30 to \$40. Each zone would still have received the same amount of money, \$10, that it was getting presently. Eight of the ten zones had approved this Bylaw change but the delegates defeated it by 8 votes. The Bylaw will stay as it is presently written.

This next year, the Central Zone will be presenting the \$1,000. Hudson Kramer Grant to a teacher (s) or a principal for enhancing their school's curriculum. The notice with the required application for this competitive grant will be sent to school districts in February 2024 with plans to award the grant before the end of the school year. Grant applications must be submitted to **Ray Pitcher** for the Grant Review Committee and are due the second week of April 2024.

Within the Central Zone over this past year, the RENY Madison and RENY Oneida-Herkimer units met to discuss the possibility of merging. After surveying their members, the units' leadership determined that the best way forward was to officially disband as of January 1, 2024, with their treasuries given to the Central Zone. A portion of each unit's treasury will be reserved for their current Friendly Service chairs, so that this work may continue for as long as the funds are available.

To continue to be active in RENY, all members of these units will need to join the state organization. All state members are automatically zone members and can remain active in the Central Zone. If these members also want to stay in a smaller unit, they should feel free to reach out to other RENY Central Zone units: RENY Cayuga, **Peg Reading**, RENY Chenango, **Mary Ann Luciano**, RENY Onondaga, **Lee Beals**, or RENY Oswego, **Collette Astoria**.

RENY Chenango provided several opportunities this year for member outreach and connection by offering its programs in various venues and in partnership with other organizations. The spring membership dinner meeting was in Greene with musical entertainment by a group that includes many retired music educators. The fall annual meeting luncheon held at a Norwich Restaurant featured a presentation from the Executive Director of United Way of Mid Rural New York. She provided members and guests with essential Chenango data about children and families. RENY Chenango members then volunteered at the United Way to help with their annual fundraising drive.

Frank Straub, Penn Yan Middle School 7th grade Physical Science teacher, received a \$1,000 Hudson-Kramer Memorial Grant on Monday, June 6, 2023, at the Yates County Retired Educators Association meeting. Mr. Straub was awarded the grant to purchase twelve digital thermometers and two charging stations for use in labs with his students to meet the Next Generation Science Standards (NGSS) beginning with the 2023-2024 school year. New York State has mandated science investigation labs, at both the elementary and intermediate levels, which expects students to demonstrate the use of digital technology and its impact on science and scientific investigations.



As stated in Mr. Staub's grant application: "*Teachers are expected to integrate qualitative scientific and technical information to support the claim that digitized signals are a more reliable way to encode and transmit information than analog signals. Students performing mastery on this standard should be able to demonstrate how the digitization of that technology has advanced science and scientific investigations.*" Teachers need to transition their classroom equipment from analog scale and tools to digital instruments, and this grant will provide the money to do so. The RENY Hudson-Kramer Memorial Grant was established to support and encourage our still active colleagues teaching in New York State public schools. The grant is given to honor the memory of **Ross C. Hudson** from Gouverneur, who was a stalwart, devoted member of RENY for many years and **Florence Coulter Kramer**, who was a dedicated veteran teacher in New York City and New Rochelle school districts. This grant will be available for the ten counties of the Central Western Zone again in 2025.





