

NEW YORK STATE Retired Teachers'

Legislative Action Mary Johnson, Vice President for Legislative Action

Each April, two of the Southern Zone units, Eastern Broome Branch and the Western Broome Branch, hold a joint luncheon meeting focused on legislation. We invite a federal or state representative to speak about education-related legislation. When Assemblywoman Donna Lupardo spoke this year there was no shortage of items to discuss and testing was on her mind and ours.

She mentioned the concern that the Governor's budget this year was referencing policy issues along with the usual financial issues. This made the choice for voting of great concern to the Assembly and Senate members. If they had not voted for the budget, Governor Cuomo could have come back with possibly less money for schools and more policy issues.

She noted that she had talked with student teachers who are scheduled for the fourth quarter of the school year. They are being short-

changed. Their teaching experiences are severely limited by the number of days and hours lost to testing and test preparation. The outcry surrounding Common

Core and testing may be discouraging future teachers from selecting education as their major. Institutions of higher learning have noted reduced enrollment in elementary and secondary education.

There was an unexpectedly large backlash from parents, students and community leaders regarding the state assessments. Many parents

chose to have their children opt out of taking the state tests. Their message to the Governor was loud and clear. Test results, however, may be skewed when not all parties take the tests. This could impact how schools and teachers are rated.

On the plus side of the budget was more foundation aid, more money for community schools and after school programs, among other items. the time you read this, the Board

By the time you read this, the Board of Regents will have produced the Regents Testing Reduction Report slated for release prior to June 30th. We will be watching.



We look forward to its introduction to members at our June Luncheon/Meeting and hope for a following of participants. There will be a table set up for sign ups, and to

learn more for those interested. Carol Lowery reports from North East Zone that they plan to undertake the NYSRTA Walkers. Janice Hedglon of Central Zone replied to news of our project with "WOW, great idea and excellent PR move!" Carolyn Cardarella of Western Zone responded with initial reception of the idea

with "This project sounds great! I'll present it to my Zone at our meeting tomorrow." Elaine Leasure of Central Western Zone planned to present to their Executive Board on May 7th.

Let me just summarize what has developed in case you have not gotten the news, yet.

We are looking for members to volunteer to walk in whatever health event is available in your zone (such as Relay for Life, Alzheimer's, Heart Walks, etc). Community Service Chairs or their designees will be filling out forms of events participated inby members; Health Chairs will be recording miles walked in events by our members, as reported to them. In September, these figures and events will be reported to the State Chairs of Community Service and State Health Coordinator. We plan to have a report on the difference we have made around the state with our walking for health causes. This is a lot of record keeping and we count on our members to get their stats to their chairs by e-mail or snail mail, as they happen. It does not have to be overwhelming if everyone takes their role in the results. We will need you to be our eyes and ears in your area and report events in your area to lo-

cal chairs, who will in turn pass the word on to State We are Chairs. hoping to get events posted on our Facebook page for NYSRTA. Also, if you cannot participate by walking perhaps you can participate by donating to the cause for a member that is walking.

The question has been asked if members can report individual miles walked on their own, and my answer to that is, that we feel this is a great benefit to individuals for their health and if they care to report that to their health chair, Gwynne Bodle, State Health Coordinator will be in charge of taking care of those stats and decide how she wants to handle that. However, for the joint project of NYSRTA Walkers, our project's goal is to not only help ourselves and perhaps improve our own health, but also to help others in need of raising awareness

Ask Bill Losey, CFP®

QUESTION: If one has a properly diversified investment portfolio, what percentage do you feel is safe to plan on withdrawing annually so that my account value never decreases?

ANSWER: As long as you limit your withdrawals to the amount of interest, dividends and capital gains generated, you won't have to touch your principal and the value of your account won't decrease. For example, let's assume you have a \$400,000 account value and by the end of the year your balance has increased to \$425,000. If you only take out \$25,000, your principal will remain intact.

For most people however, limiting their withdrawals to only interest, dividends or capital gains isn't realistic because most people don't hold investments that only go up in value. In short, their portfolios rise and fall in value with the normal stock and bond market fluctuations and could be worth more or less than their original investments. Additionally, most people (unlike teachers) won't have a pension so they'll have to rely heavily on an income stream from their portfolio. In many cases, these portfolios are scheduled to be depleted over time.

The issue of not running out of money and creating a sustainable income is hard because we don't know how long we're going to live. I mean, when you retire, will you be around for 10 years or 30+ years? It's anyone's guess; so you'll have to monitor your withdrawals at least annually.

BILL'S BOTTOM-LINE: The less money you take out, the lower inflation is, and the higher return you earn on your money, the longer it will last. Conversely, the more money you take out, the higher inflation is, and the lower your return is, the shorter your nest egg will last.

The Robert R. DeCormier Memorial Trust Fund

Robert R. DeCormier was the first president of NYSRTA, and a dedicated advocate for retired educators. In memory of his service and to honor his commitment to past, present, and future colleagues, the Robert R. DeCormier Memorial Trust Fund was established. This fund provides monetary assistance to retired educators who are in financial need. Presently the DeCormier Memorial Trust Fund provides a monthly stipend to help eight retirees meet necessary expenses. In many cases the recipients of these grants have pensions and other benefits so meager that they are not able to meet their financial obligations. Letters of appreciation that the Board of Trustees receive are truly indicative of the gratitude the recipients feel. The quotes below are from actual letters that some recipients have sent:

Just a note to say how much appreciate all you do for me. Without your help my being in my home wouldn't be possible.

The amount provided by the DeCormier Memorial Trust has enabled me to meet a majority of my expenses that are not covered by my basic income. Without this by my basic income. Without this financial assistance, I would be forced to choose between food, medication and other expenses.

How about you? Are you able to pay your monthly bills with your monthly income? The DeCormier Trust Fund offers two different grants to assist NYSR-TA members who are in need of financial assistance:

The *Special Grant* is a lump sum grant that can be used to pay for an unexpected, un-reimbursed emergency expense, such as a necessary furnace replacement.

The *Monthly Stipend Grant* sends a check to the grant recipient each month to supplement other income, such as a pension, as long as there is a need shown.

To be eligible to apply for a grant, the applicant must: (1) be a current member of NYSRTA with a minimum of three years of immediate prior membership, (2) be at least 55 years of age, (3) have (or member's spouse have) a minimum of fifteen years as a New York State school employee, (4) complete and submit an application which can be obtained from; the NYSRTA website (www.nysrta.org), by phone (1-518-482-3509), or by written request (8 Airport Blvd., Latham, NY 12110), from a DeCormier Trustee, or from a Zone or Unit Friendly Service Chair.

Both applications require information about the applicant's assets (such as cash, checking, stocks, insurances, pensions, social security, etc.), debts, and financial obligations, as well as other information that may help the Trustees to fully understand the circumstances of the situation. The completed application is mailed to the NYSRTA office. All application information is held in strict confidence.

Each grant request is investigated to determine that there is a legitimate need. After a thorough discussion of the application, the Trustee Board renders its decision of whether or not to accept, or possibly modify. The applicant is then notified of the Trustee Board's decision.

We encourage you to reach out to us if you need help, or to forward this information to a fellow retiree who may be experiencing difficulty. Truly, the memory of our first NYSRTA President Robert DeCormier is kept alive through the financial help that NYSRTA members are able to give to fellow retirees in need.
