

Resolutions Committee Report Gayla LePage, Chair

The Delegates to the 2016 NYSRTA Annual Meeting approved four proposed new resolutions and one emergency resolution as recommended by the Resolutions Committee.

The approved measures are printed below. The necessary additions will be made to the "Be It Resolved..." document that can be accessed on the NYSRTA website.

A special thanks to the zones who submitted the proposals and to the Delegates for their acceptance of these statements.

Resolution D-19-1: Return Cursive Writing to the Elementary Classroom (Western Zone)

THEREFORE, be it RESOLVED that the NYSRTA urge the New York State Department of Education to return cursive writing to the elementary.

Resolution E-16-1: Ethics Reform in the **State Government (Western Zone)**

THEREFORE, be it RESOLVED that the President of the New York State Retired Teachers' Association (NYSRTA) contact the Governor, Assembly Speaker, Senate Majority Leader, and the Chairs of the Senate and Assembly Ethics Committees expressing our deep concern over the lack of ethical behavior that currently exists, and

Be it further RESOLVED, that the NYSRTA President strongly encourage these state leaders to immediately initiate and enact meaningful ethics reform, and

Be it further RESOLVED, that the NYSRTA President contact these state leaders on at least an annual basis, reinforcing the need to accomplish common sense, good government reforms, and expressing appreciation for any reform that may have been adopted since the last contact.

Resolution E-17-2: Mandating Seatbelts for All NY State Backseat Passengers Aged 16 or Older (Long Island Zone)

THEREFORE, be it RESOLVED that the NYSRTA support legislation to require all rear seat passengers 16 years or older to wear seat belts in New York State.

Resolution E-18-3: A Resolution to Oppose the 2017 Constitutional Convention Referendum Initiative (Northeastern and Long **Island Zones**)

THEREFORE, be it RESOLVED that the NYSRTA opposes the approval of the Constitutional Convention referendum, and

Be it further RESOLVED you will be asked to vote on November 7, 2017, if we should hold this convention. NYSRTA urges you to vote NO; and

Be it further RESOLVED that the NYSRTA broaden its arguments of opposition to the convention by including other groups who could be harmed by the convention, and

Be it further RESOLVED that the NYSRTA make every effort to participate with coalitions representing both retired and active educators, as well as, other special interest groups who could be harmed by proposals made at the New York State Constitutional Convention, and

Be it further RESOLVED that the NYSRTA inform its members on these other issues and join the broader media campaign.

The following is the emergency resolution that was approved at the 2016 annual meeting.

Resolution D-19-1: Repeal the Teacher Registration Regulations (Central Zone)

THEREFORE, be it RESOLVED that the NYSRTA seeks legislation to repeal the Teacher Registration Regulations for all New York State Educators.

CREATIVE TEACHER WINS FIRST EMPIRE STATE EXCELLENCE IN TEACHING AWARD

June 2016 was a very important month for NYS teachers. Governor Andrew M. Cuomo came to Buffalo to present the first recipient the Empire

State Excellence in Teaching Award. This recipient was recognized having exemplified the highest professional standard of teaching and work. He instills a love of learning by ensuring school is exciting, mo-



tivational, and challenging. Governor Cuomo said further regarding teachers, "You need patience to be a teacher. You need tolerance to be a teacher. You need to keep up on education to be a teacher. You need to be creative and engaged and you need to stay creative and engaged and that's hard."

Adam Norris is the recipient of the first Empire State Excellence in Teaching Award and he lives in the Buffalo area. Adam Norris is a social studies teacher at Maryvale High School since 2006. He uses a "flipped classroom" method in his teaching of his APUSH (Advanced Placement US History) students. Mr. Norris creates videos which range in length from 5-15 minutes. Students watch the videos and write down the important information of the day. After the video, Adam Norris discusses the material with the students and addresses any questions they may have. The remainder of the class is spent practicing multiple choice questions, thesis statement writing, and document analysis. Adam has made over 400 videos. They are on youtube.com, and he encourages other students and teachers to view his videos and use them for teaching/learning. Mr. Norris estimates that the 5-10 minute videos replace 40-45 minutes of notes in the classroom. This method gives the teacher time to help students with their writing and more time to talk to students individually. He can meet with students in small groups and provide immediate feedback.

Adam Norris has won the 2015-2016 first Empire State Excellence in Teaching Award, which was created to recognize teachers who inspire students and help them to learn in new and unique ways. Adam is the first Teacher Ambassador. New York State is finding the best teachers and identifying them, acknowledging them, thanking them with a \$5,000 stipend, and asking them to tell their story to other teachers. These other teachers can create, copy, or emulate the Teacher Ambassador, eventually to also become one of the best NYS Teachers.

During our years of teaching, mentoring, supervising and evaluating student teachers, we sometimes found a diamond in the rough, and hoped they would eventually be a Teacher Ambassador with a little help from us.
