Two of the most crucial issues that are facing our Association are **Membership** and our current **Financial Status**. We are embarking on a program to reduce costs without hurting the organization as a whole. We must work to get a balanced budget. In order to balance the budget, we must cut costs or increase revenue. We are making progress; in 2015 we took out \$165,000 from our assets and in 2016 we took only \$60,000 from our assets.

In March I sent out my President's Appeal Letter. To date the Appeal Letter has been a great success. **Don't forget to send in your donation**. Don't forget that your donation helps to support our Friendly Service, Community Service, and Health Care. Remember, NYSRTA is one of the few organizations that have worked for educational retirees and helped them maintain their retirement benefits throughout the years.

We are currently dealing with the issue of the **2017 Constitutional Convention.** This can hurt teachers, as well as all state employees. This Convention will hurt our pensions. There is talk that they may want to tax our Pensions and do away with Collective Bargaining. The public will be faced with the cost of millions of dollars to run this Convention. I suggest you vote NO on the ballot

in November, 2017 to have a Constitutional Convention. If you vote yes, this convention may run until 2019. We are still working with the Alliance of Public Employees and RPEA (Retired Public Employee Association) to stop the 2017 Constitutional Convention.

We also made another change. Our Executive Board Meeting this past March was held at the Syracuse/ Liverpool Holiday Inn. We found the new venue very accommodating and will have our future meetings at the new location. The Radisson in Utica, NY was unable to fill our needs.

I have also been investigating possible venues for our State Convention. I visited a convention center in Saratoga Springs, New York, but we found that it didn't meet our needs and it was more expensive. I also plan to visit the Courtyard Schenectady at Mohawk Harbor in early May to see if they can meet our Convention needs.

I would like to thank all the Zone Presidents and their members for all they do for NYSRTA.

I would also like to thank our staff at the Albany Office for their hard work and dedication. Thank you to: Kathi Bassett, Executive Office Manager, Debbie Barnes and Lillie Ruby.

## A "Letter to the Editor" published in The Press Republican in Plattsburgh, January 2017, from Kevin Mulligan, Vice President

To the Editor:

The January 5, 2017 editorial, "In My Opinion", by Dr. Peter Galie and Christopher Bopst was democratically spirited in a utopian sort of way, but was seriously lacking in the truism of Albany politics. Their article focused on several, idealistic reasons favoring a Constitutional Convention in New York State that is scheduled for a referendum vote on November 7, 2017. A "yes" vote on the referendum would begin the two year process for a convention. A "no" vote ends the process for having a convention.

It was noted that the New York State Constitution has experienced 228 amendments since its inception

been a result of legislative action by our elected officials. What they did not convey is that the latest cost estimate to hold a Constitutional Convention in New York State is \$340 million. That cost would be incurred by the taxpayers of New York State. They also failed to mention that most, if not all of the delegates to that convention would be made up of legislators, representatives of lobbying groups, and/or close associates of legislators. I need not remind the North Country that any Constitutional Convention would heavily favor New York City and the metropolitan area.

Their article inferred that a State Association

in 1894. The majority of those have Convention would perhaps clean up the corruption in Albany. The New York State Legislature has always had the power to do that, but has repeatedly shied away from cleaning up the Senate and Assembly. Without question, we do have a democratic process that could ensure a "clean up" of the corruption in Albany, and that is to support and vote for legislators that will work tirelessly for that cause through legislative action. We cannot afford the "good old boys" of Albany to have a Constitutional Convention.

#### SCHEDULE FOR PROPOSING RESOLUTIONS

All proposed resolutions must be submitted to the State Chair of the Resolutions Committee "thirty (30) days before the July Executive Committee Meeting". The date of that meeting is July 18, 2017. Thirty days prior to that date is Saturday, June 17, 2017. I am asking for resolutions to be submitted by June 14, 2017 so I can have time to prepare them for the meeting.

When submitting proposals, please adhere to all of the guidelines that are clearly spelled out on pp. 78-80 of the Leader's Manual.

Each proposal should be on a separate page with the proper attestation and signed and dated by the Zone President at the top. Each proposal should specify which NYSRTA objective(s) is being addressed in the proposal. These are found in Article II of the Bylaws. A signed card must be sent to me (189 County Route 16, North Bangor, NY 12966) along with an electronically transmitted copy to luer913@hotmail.com.

Zones considering the submission of a proposed resolution should:

**1.** Examine, in depth, whether the intent (purpose, aim, action required, or the like) is clearly an expression of one or more to the Article II of the By-Laws. Is the intent something that should be expressed as a resolution, something that requires a By-Law change, something that necessitates action by the State Executive Committee, or a change by another committee or agency?

- 2. Research thoroughly the proposed resolutions.
- 3. Make certain the "Whereas" statements and the "Resolved" are clearly stated. This is extremely important as the Legislative Action Committee will return to us or table the unclear proposed resolutions.
- 4. Submit the proposed resolutions as early as your zone's schedule permits, allowing time for review by the Zones' Resolution Chairs as well as by appropriate NYSRTA committees.
- 5. Submit up to but no more than three (3) resolutions for consideration in a given year.

## DeCormier Financial Assistance, Imogene McKendrick \*CR

Are you having difficulty "making ends meet" financially? Do you find that paying that bill for your latest visit to the doctor or dentist has prevented you from staying within your budget? Your membership in the New York State Retired Teachers' Association (NYSRTA) allows you to be eligible to consider applying for a grant from one of two offered by the Robert R. DeCormier Memorial Trust Fund.

Which grant should you choose? Read the following brief descriptions. Find the one that will best help you to meet your financial need, and then contact your Unit or Zone Friendly Service Chairperson or call the NYSRTA office (518) 482-3509 to obtain the grant application that you will need. Complete the application and send it to the designated address. The **Robert R. DeCormier Memo rial Trust Fund** offers two different types of grants. Guidelines for eligibility include: current and at least three years of membership in NYSR-TA, a minimum of 15 years as a certified or non-certified staff member in an educational institution, or the member spouse of such a member or deceased member, and a financial need or special circumstances requiring financial aid.

A Special Grant offers a "lump sum" to Association and spousal members in financial need. It provides financial assistance for an unexpected, un-reimbursed expense such as a new roof, extensive dental work, or an unusually high utility bill. The amount of the grant is dependent upon the applicant's shown need. Contact your Unit Friendly Service or the NYSRTA Office to request a DeCormier Trust Fund *Special Grant* application form. When the form is completed, send to: DeCormier Trust Fund – NYSRTA, 8 Airport Park Blvd., Latham, NY 12110-6414.

#### An Interview with Stella Courtney Mary Ellen Johnson, Schenectady

County Retired Teachers Association (SCRTA) historian

Although, in our lifetime each of us add a line or two to our nation's ongoing historical narrative and occasionally, one individual contributes a whole paragraph. Stella Crockett Courtney was one of those trailblazers who helped change our country for the better when she became the first African-American to graduate from Texas Tech in 1965, after attending four consecutive years (1961-1965). Many of you may have viewed her on a recent segment of WNYT's Elaine Houston's regular evening program when Stella was featured as one of "Capital Region Women Who Helped Make Civil Rights History." Stella Crockett grew up in a hardworking and religious family in Lubbock, Texas during the era of segregation and "separate, but equal" schools and public facilities. Living in the African-American section of the city, she attended all black schools taught by an all-black faculty. These dedicated teachers inspired her desire to attend college and become a teacher herself. Her full scholarship to the historically black Langston University in Oklahoma would have given her a free education. However, that summer, after her graduation from high school. the announcement that Texas Tech in Lubbock would finally begin accepting African-Americans for fall classes changed her plans. A diploma from this highly rated university was an asset in any career. When her high school band director contacted her, urging her to apply, her parents also agreed that she should go to Tech.

This was a huge financial sacrifice for them with the cost of \$300 per semester, a very sizable sum in 1961 dollars.

As Stella began her freshman year at Tech, there were only a tiny handful



of other African-Americans on a campus with over 2,750 white students. She faced little overt hostility, but fellow white students generally kept their distance, refusing to sit next to her in classrooms unless no other seat was available. One of her worst experiences happened early on, when, as she sat in the front row, the first day of her psychology class, the professor used the N-word as part of his lecture. Stella dropped the course, figuring she had no future there. During her four years at Tech she found that some professors were "real ugly and mean," while others were grudgingly accepting, and a few as "nice as sweet potato pie."

Stella was one of the few African-American students who played in Texas Tech's band. When the band was honored and invited to play at newly elected Governor Connelly's inauguration in Austin, the two or



three black women in the band were notified they could ride on the bus, but could not stay in the same hotel as the white band members. The black women decided not to go. Stella can't remember ever traveling out of town with the band. She

performed only on their home field.

Another, never to be forgotten incident, was being in the cafeteria sitting at a table with some fellow African-American students when the announcement of President Kennedy's death was made. A group of white, male students jumped up, cheering and shouting, "Thank God, the N-lover is dead."

Because dorms were not yet integrated for a few years, Stella commuted back and forth from home. Despite unpleasant experiences, her focus was on completing her degree.

Texas Tech's 1965 commencement ceremony was the first to award a diploma to an African-American student who had spent all four years there as an undergraduate. Stella recalls, "I felt

really good that I made the achievement. It was a milestone for me and my family."

The Lubbock public school system offered her a teaching job, which she declined. During student teaching, Stella discovered she had a real aptitude in reaching special needs and challenged youngsters. Her supervising teacher encouraged her to teach special education. This led to a 43 year career teaching elementary special education. Leaving Texas, she began teaching in Albuquerque, NM. There she met her husband. They relocated to Michigan where they worked on additional college degrees. They went to Rhode Island where a change of pace found her work-



ing with young adults with special needs. The next move was to Rochester N.Y., and finally, to Clifton Park, where she still lives today. This brought her to the Schenectady City School System teaching elementary special educa-

tion. She was assigned to several of the city's elementary schools during her 33 years in the district.

Now that she is retired, Stella continues to work with children and adults as the Sunday School Superintendent of St. Johns Church of God in Christ. She and her husband have celebrated their 50th anniversary. They enjoy the company of their two children.

An annual trip to Texas allows her to connect with extended family and catch up on what's going on

> at Texas Tech. Just recently, she has been recognized at her alma mater for her pioneering breakthrough at the university, by being featured in a special diversity exhibit at Texas Tech's

Southwest Collection Library. This exhibit highlighted people who have helped to create the institution's diversity. For her contributions to both civil rights, and in the field of education, Stella's photograph, a description of her accomplishments and her oral history are part of the display. Interviewed for two lengthy articles in the Daily Toreador, the school's student newspaper, she noted, "I never thought it would be as integrated as it is today."

SCRTA is honored to have Stella Courtney as our Assistant President, a woman who was not only a dedicated educator, but also a Texas civil rights pioneer.

In early 2017, there was a Rally For Education held in downtown Plattsburgh at the MacDonough Monument. Afterwards, there was

an opportunity for educators to get Linda Crosby, Public Relations Chair together for round table talks at the local NYSUT office to discuss concerns. There was a crowd of about 60 people at the rally and about half of that number met afterwards. It is known that active teachers have a difficult time attending events in the evening due to their family obligations and their preparations for the classroom the next day, so it was no surprise that most of those in attendance were retirees, and NYSRTA members at that! The discussions focused on how schools are perceived and what activities could enhance those perceptions. Days and weeks later, article after article appeared in the Press Republican highlighting many of the innovative programs that our local school districts are implementing.

In that vein, this spring, NYSRTA offered a \$1000 memorial grant in the name of public school teachers Ross C. Hudson and Florence Coulter Kramer. The Hudson-Kramer Grant opportunity is open to active educators who have an innovative project or program they would like to implement in their classroom or school building. Notification of the grant and applications were sent out to each school district in Clinton and Essex counties through the District Office of Dr. Mark Davey at BOCES. In addition, the information and applications were sent to a teacher association representative. The deadline for submission was May 5th. At the time of this publication, 6 applications have been received, and others were on their way. The winner will be announced at the June 9th NEZ meeting and the successful applicant will be recognized. Those of us on the committee are looking forward to reading the applications and finding out what kinds of creative, innovative projects these educators have in mind for their students.

The Bylaws Committee is presenting four proposed bylaws changes for consideration at the 2017 Annual Meeting in October. All four of them were approved by the Executive Board at it's March meeting. A summary of the four propositions follows. The 2017 propositions have been posted on the web site at www.nysrta.org/ bylaws, along with an updated copy of the complete NYSRTA Bylaws (also on the NYSRTA face book page). Four of the propositions are holdovers from the 2016 Annual Meeting. The delegates accepted two at that time, while one was tabled and the delegates voted one down. Due to a technicality, no actions on bylaws taken at that meeting had validity and therefore must be presented again. I wish to thank the members of the committee for all of the hard work and time they have put into preparing these propositions.

The Bylaws Committee recommends approval of all four propositions.

#### Proposition MD (Member Disgualification ) 2017

This proposition allows the association to deny membership to anyone who has been convicted of a crime that, under New York State Education Law, would have barred him/her from holding State Education Department Certification as an Educator, whether or not he/she actually holds such certification. This covers all three classes of membership: Educator, Associate, and Spouse.

#### Proposition ENLM (Eliminate New Life Memberships) 2017

This proposition removes the option of new Life Memberships as a cost saving measure. Present Life memberships in good standing would not be eliminated.

#### **Proposition RUVEM (Remove Unanimous Vote Require**ment at Electronic Meetings) 2017

This proposition was initiated after a review of our bylaws with SAANYS attorney Wendy S. DeForge, Esq., who said that it was not in compliance with the New York State Not-For-Profit Corporation Law. This makes sure that the Bylaw that was passed in 2015 is in compliance with the law.

#### Proposition NFPLC (Not For Profit Law Compliance) 2017

This proposition allows voting-enabled substitutes for all members of the Executive Board not already covered by the current bylaws. Legal advice has revealed to us that the NYSRTA Bylaws are not presently in compliance with Not-For-Profit Law in that we do not have the required functioning Board of Directors. Proposition NFPCL 2017 will accomplish the mission while rectifying the legal compliance issue with the NFPL.

## Legislative Action: Mary Johnson and Gary Germain, Co-Vice Presidents for Legislative Action

The Legislative Action Committee met on March 26 and 27 in Syracuse to finalize the selection of legislative priorities for 2017. The legislative agenda was approved on March 28 by the Executive Board. The legislative priorities were the offshoots of resolutions passed at the October convention. And these same issues were discussed during our Legislative Action conference call in January.

Two of our state legislative priorities continue to be the <u>Mini-</u><u>mum Pension Bump Up</u> and a bill to <u>Improve Pension Cola</u>. Our state campaign card also includes the following statement: Over the years, we have had the pleasure of meeting with our local legislators and advocating for many issues. We have found them to be honest and ethical. We ask these same legislators to enact ethics reform bills that would remove and punish any colleagues whose actions jeopardize the trust and respect earned by the majority of elected representatives. NYSRTA supports meaningful ethics reform through the passage of legislation and referendum process.

At the Federal level, we have also decided to pursue three bills that we have been advocating for several years. These include the following: Negotiation of Covered Medical Part D Covered Drugs. This bill would allow the Secretary of Health and Human Services to negotiate with drug companies to reduce drug prices. We are also advocating a bill for Strengthening Social Security and Medical Trust Fund. This bill supports an increase to the average beneficiary, of \$800 per year. It would also change the cost-of-living calculations to reflect the living expenses of social se-



curity beneficiaries. The third bill we are advocating for (<u>Observation vs.</u> <u>inpatient for coverage under Medicare</u>) deals with the status of a patient under hospital care. A person whose status is "under observation" may not be covered under Medicare for any subsequent followup care in a skilled nursing facility. It is imperative that one be admitted as "inpatient" to be covered by Medicare.

Also while in Syracuse, Mary Johnson, Gary Germain and Bill Lesniak visited the offices of Senators Schumer and Gillibrand. We were well received by the staff members of both Senators and informed that they support our legislative causes.

I remind all NYSRTA members that the likelihood of a Constitutional Convention is still very real. The recent approval of the late State Budget is a testament to the movement to use a Constitutional Convention to remove the corruption in Albany. The reality exists that many of the same state legislators, both corrupt and not, will serve as delegates to that convention. We are also confronted with a possible taxpayer burden of up to \$340 million to pay for that Constitutional Convention.
