#### **Anne Flansburg**

Who is Anne Flansburg? Some would answer: She's the tall one who is kind and generous (to a fault) & friendly & hard working and much more. In our zone and the state organization she has always accepted whatever assignment that has been asked of her.

Anne's teaching career spans over 30 years. She started as a Math teacher at Lafayette high

School in Buffalo. Her ability to organize was well recognized. She helped to raise funds for student activities. From there she went to Performing Arts and helped to establish a program in Math at U.B. for gifted and talented. But it was at Seneca Vocational where her career expanded into an assistant principal's role and finally as Principal of Seneca from where she retired.

She did not stop her activities however. In 1998 she joined the Western Zone of NYSRTA where she was chair of several committees at one time or another. Among others, she was chair of membership (a most important committee), remembrance committee (which commemorates deceased members), and travel (which she still heads). She was also nominated and elected to the position of Vice President and President of our Western Zone. She presently heads the DeCormier Trust which gives financial aid to retired teachers in need of monetary assistance to cover unexpected costs, e.g. new roof, unforeseen medical costs and the like.

We could also call her a patron of the arts, supporting the Kavinoky Theater and volunteering at Studio Arena, Artpark, and Shea's. She has been a volunteer tutor and Amherst Youth Board volunteer. She has hosted students from Switzerland, Japan and Russia.

Most of what is written concerned the local level of activity. But Anne has also participated in the state level of NYSRTA. She worked on committees who award certificates of honor at the state convention every October. As vice-chairman of membership, she has been tireless in striving to increase the membership in NYSRTA and members are the lifeblood of the organization.

All in all a pretty active woman and one who does not seek the limelight but deserves the admiration of all that know her and recognition for what she does.

### **Betty Browne's Health Tip**

#### Do You Need a Hearing Test?

This article was written by Dr. Burkey and appeared in the "Bottom Line Health" Publication. It contains good advice for everyone and especially retirees. If you have not had a hearing test recently, please consider getting one.

"The American Speech, Language and Hearing Association recommends a hearing test every 10 years for adults up to age 50 and every three years thereafter. A hearing test may be recommended sooner if you or your family are worried about your hearing loss; you have family history of hearing loss; you have a loud hobby, such as wood working or recreational shooting; and/or you work in an environment with loud music or noise. Hearing tests can be performed by an audiologist (specialist in hearing disorders) or and ear, nose and throat (ENT) doctor. Some insurance plans cover hearing test. Check with your provider.

**Important**: Tinnitus, random ringing or chirping in the ears when there is no actual sound, is often a sign of impending hearing loss. People who experience this condition should consider getting their hearing tested.
