

## A Message From Our President, Dr. James Newell, PhD



As we prepare to go to press for the summer issue of *York State*, we are all thinking of warm weather and all the special outdoor activities we love to do. Some of us have already hit the links. Others are gearing up for outdoor tennis. Some people are getting out their gardening tools and gloves, while others are out walking and cycling. Many of us cannot wait to visit our cottages and camps or to take a trip to the beach.

In Black River, we have had a frost warning for the last two nights, but the weather is getting warmer day by day. Often people ask me, how am I doing? My stock reply is that I am always good when the sun shines! Lately the sun has been shining frequently. When it shines through my window in the morning, I am reminded that it is time to get up and get moving. That's right. We need to get moving. I mean that literally and figuratively. We need to attract new members to RENY, stabilize the membership numbers, and provide new opportunities for our members to learn and grow. Most importantly, we need to plan and hold those luncheons and breakfast meetings, reach out to our

As mentioned in my previous message, **RENY is not generating sufficient revenues to support our operations.** Memberships dues, the President's Appeal, and the dividends/interest earned by our investments all declined this past year. At the same time, RENY expenses were higher. During the last seven years RENY/NYSRTA has taken many steps to reduce expenses. Reducing expenses further will harm our organization and hamper its ability to serve its members.

In July, the Board of Directors will be asked to make some difficult decisions. It will be asked to consider changes to membership dues. It will also be asked to consider reducing the percentage of membership dues rebated to the zones. I am asking you to support the decisions made by the BOD. It is vital that we generate sufficient revenue to support our organization and to keep it moving forward.

The Workshop Committee under the leadership of **Gayla LePage** has worked steadily over the last several months and is putting the finishing touches on what promises to be a great Convention. I would encourage you to consider attending this event planned for October 11-13, 2023, at the Turning Stone Resort in Verona, New York. Please refer to pages 6 and 7 for more information on the workshops offered.

The Website Development Group met three times via Microsoft Teams. This group consists of **Kathi Bassett, Marilyn Dominick, Terry Satterley, David Schryver, Lois Thornberg**, and yours truly. At the most recent meeting on May 18, we reviewed the results of the Website Survey and formulated some recommendations to improve the website. These recommendations will be presented to the BOD for action in July 2023.

As I close this message, I remind you that RENY is the only state-wide organization that works exclusively on behalf of retired educators. It is a great organization and I thank you for continuing your membership in RENY. My wife Patricia and I hope to see you at our Convention or when we visit your zone. ## PRESIDENT'S APPEAL

The President's Appeal is one of the three largest and most important sources of revenue for the Retired Educators of New York. It was originally designed to offset the loss of membership dues coming to the Association from three different categories of members.

The first category was members who selected lifetime memberships. The dues provided by lifetime members were collected and expended during the year in which the membership was purchased. Thus, these dues are a one time revenue. They do not reoccur annually. It was assumed and expected that lifetime members would contribute to the President's Appeal since they were not paying yearly dues. According to the most recent membership report, RENY has 3787 lifetime members who are less than 90 years old.

The second category of members are members who attain the age of ninety (90). For these members, membership dues are waived as a perk for belonging to the Association for many years. Believe it or not, RENY currently has 1761 members who have attained that age!

A third category is RENY members who have reached the century mark. At the last membership report, there were 210 members who were one hundred years old and older. The membership dues of this group are likewise waived as a perk for belonging to RENY for many year and for reaching this remarkable milestone.

According to Richard Young, Chief Actuary of the New York State Teachers Retirement System, the life expectancy of teachers exceeds that of the general population. On average, female retired teachers have a life expectancy of 86 years, while retired male teachers can expect to live to 84. We celebrate the fact that our members live long and productive lives. It is our belief that the social interaction, life long learning opportunities, service to the community, and the chance to be involved in worthwhile activities contribute to that longevity. RENY plays an important part in keeping retired teachers learning and growing.

The President's Appeal this year was launched in April. The goal for the year is to raise \$60,000. Kathi Bassett and Kris Valentine reported that to date, we have raised \$54,469. Thus, we are 91% of the way to our goal. Knowing the importance of this fund, I encourage every RENY member to make a gift to the 2023 President's Appeal.

Summer is one of the favorite seasons of the year. But with sunshine and outdoor fun can come summer health risks. Listed below are a few.

### **SKIN PROTECTION**

Skin cancer is more common in people who spend a lot of time in the sun, so if you are going to spend a lot of time soaking up the rays, be sure to use a sunscreen. Check yourself for changes in moles and freckles every few months. Particularly those with fair skin should see their dermatologist for a cancer screening annually, or even semi-annually.

### **STAY COOL**

When the temperature is near 100°, beware of heatstroke. Extreme heat exposure can result in symptoms like confusion, shortness of breath, inability to sweat, and a fast pulse. Heat stroke can be life threatening, so call 911 right away. In the meantime, cool the body with ice and cold water.

### **FOOD POISONING**

Summer and eating outside go hand-in-hand. Remember to keep cool foods cool and hot foods hot. Cold food left out more than an hour in 90° weather may not be safe to eat.

### **BUG BITES**

A bug bite can be more than an itchy inconvenience, if it carries an infectious disease like Lyme or West Nile Disease. Protect yourself by wearing long sleeves and pants in buggy areas and use a good repellent.

## Membership Report —By Dell Ford Jordan, VP for Membership

*“Strength and growth come only through continuous effort and struggle.” – Napoleon Hill, author*

This quote is right on the money. As we struggle with our membership having a continuous decline, we must put forth effort to turn that decline around, continuous effort. Let’s start off by talking stats. We started off the year at **11,941** (October 2022) and now we are logging in at **10,741** members for the period ending May 31, 2023. That’s a loss of **1,200** members either by not paying their dues or due to their passing. Since October 1, 2022 we have mourned, and are now grieving, the loss of **317** members. There is no replacement for the members we have lost through death; we have enrolled **66** new members to replace a portion of the numbers lost. We have **808** 90-year-olds, up from **803** and our 100-year-old category has increased from **119 to 147**. **That is truly a blessing.**

Membership Chairs from the Zones and Units are working to develop plans and incentives to help increase our membership. We are sharing our ideas and are working cohesively to bring new members into our organization and reclaim those who are delinquent. The Membership Team supports all efforts to improve RENY’s membership and finances and encourages you to submit your ideas.

GENTLE REMINDER: The incentive of \$50 for every five (5) members you enroll in RENY is still in effect. There is no limit on how many members you can enroll in one year. Just remember to put your name on the application so we will know who gets the credit.

**The Northeastern Zone** is in the **Spotlight** once again. At the end of May 2023 an increase 17 new members were added to their numbers keeping them on target for another First Place win. But don’t despair, **Western Zone, Central Zone, and Central Western Zone** are catching up. We do have 6-months to go before the winner is determined.



**Congratulations to all the Zones for your efforts to increase our numbers!** We thank you for your initiative and commitment to RENY. **THANK YOU!**

## Legislative Action Report —By Mary Johnson, VP for Membership

It has been an interesting legislative year between the federal government’s debt limit crisis and the state’s late budget passing. Education fared well with this year’s State budget including the long-awaited fully funding of foundation aid and an increase of general aid to schools of \$3billion, 9.4% over the 2022-23 school year.

RENY’s State Legislative Priorities for 2023 are:

1. Supporting efforts to protect public employees’ health benefits and prohibiting diminution of benefits.
2. Supporting programs and bills that provide pathways to retain current teachers and ways to resolve the teacher shortage.
3. Supporting the creation of a central registry of incidences of elder abuse so that abuses can be reported and abusers face the legal consequences.
4. Supporting mental health services for students within the school setting.

RENY’s Federal Legislative Priorities for 2023 are:

1. Support legislation to ensure the long-term financial security of Social Security and Medicare programs.
2. Support legislation that increases availability of school-based mental health programs and services.
3. Support for legislation that ensures communities have well-qualified school teachers and personnel.

RENY’s advocates are visiting legislators or their legislative aides this spring and early summer. We are always in need of more people to help with this process. Please contact me of the RENY office if you would like to help .

### Interesting Facts About Jefferson County

The Philadelphia Cream Cheese and Thousand Islands Dressing originated here, along with Woolworth's Five and Dime Store, the Dewey Decimal System, and Arbor Day.

### Interesting Facts About Lewis County

The county was named after famous American explorer Meriwether Lewis, best known for his role as leader of the Lewis and Clark Expedition. The first settlers in Lewis County came from Vermont and Connecticut in the early 1800s. They primarily engaged in farming, lumbering, and trade activities. In the late 19th century, the county became known for its thriving cheese-making industry, with many local farmers producing high-quality cheddar cheese that won international awards. Lewis County played an important role in the Underground Railroad, a secret network of people and safe houses that helped slaves escape from the South to freedom in the North.

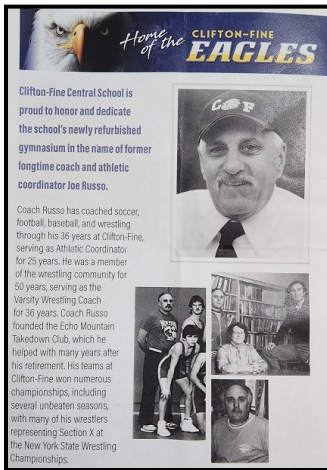
