LEGISLATIVE ACTION COMMITTEE REPORT

The Legislative Action Committee has been meeting virtually since December to finalize the Legislative Priorities that RENY advocates will discuss with our State and Federal Representatives. These priorities are based upon resolutions passed over the years by RENY delegates and with approval of our Board of Directors.



You know the issues you face living in NYS as a retiree and as a senior. Affordability is not just a word for us; it is a survival reality. The price of a dozen eggs is trivial compared to overall food expenses, rising utility rates, increases in prescription drug costs, co-pays for doctor visits, increases in all types of insurance premiums (health, car, homeowners, and long-term care insurances).

Our oldest retirees who have the smallest pensions are most likely living in poverty. Our COLA increases fall far short of keeping pace with inflation in an economy benefiting the rich but not you. Cuts to programs at the federal level including the dismantling of the Federal Department of Education and cuts to personnel especially in the Social Security Administration will directly or indirectly affect every resident of New York State.

There is no easy solution, but it is important that our representatives hear our stories. If you are unhappy with the state of affairs, you have the power for change, you have a voice, you have a vote. As the election process for 2026 begins, make your vote an informed vote.

ROBERT R. DECORMIER MEMORIAL TRUST FUND REPORT

The DeCormier Memorial Trust Fund was established to assist retired educators facing financial challenges. The Fund provides both monthly stipends to retirees who are struggling to meet their regular expenses and special grants for one-time expenses that are beyond the means of the retiree. In the past five months we have approved four grants – one to help bridge the gap between insurance and savings to pay for repairs to a roof damaged in a storm; another to pay for furnace repairs; a third to purchase a new computer for a disabled retiree which is used, in part, for teleconferencing with medical specialists that are located over 100 miles away; and a fourth to pay for the replacement of a 54-year-old front door and storm door. In addition, we are awaiting more information pertaining to a request to help fund the replacement of a leaking roof. We also performed our biennial review of the monthly stipends awarded through the trust. The circumstances of the current recipients and the increase in the cost of living over the past two years were taken into consideration and stipends were increased accordingly. Speaking for all of the trustees, I can say that it is an honor and a pleasure to be able to help fellow retirees who need financial assistance in difficult times. Thank you to all of you who have supported the DeCormier Trust and made this possible!



An amplification system is a microphone the teacher wears that sends out the voice to be picked up by the speaker device, helping to cancel out extraneous noise. The school is presently located in an older building in a neighboring district due to flooding in 2021 and 2024, and the classroom environment is very loud due to older heating equipment.





President Emeritus Kevin Mulligan*CR invited two members from our Insurance Consortium who



provided information regarding the changes to the Platinum Plan A. It was a great start for December.







So there you have it. Do things really change, stay the same, or a little of both?




SCRTA, Schuyler County Retired Teachers, haven't had a meeting due to weather and time of year. However the Board still continues to meet to make plans for its members.
